# FLORIDA ATLANTIC UNIVERSITY NOTICE OF PROPOSED REGULATION AMENDMENTS

Date: July 6, 2012

**REGULATION TITLE AND NUMBER:** Use of University Property and Facilities (6.005).

**SUMMARY**: FAU Regulation 6.005 addresses procedures related to the use of University property and facilities. The proposed amendments update the language to delete outdated references and to clarify the delegation of authority to the University President to implement such procedures through the University's policy process. This regulation amendment shall be effective August 6, 2012.

### Regulation 6.005

## **Use of University Property and Facilities**

Florida Atlantic University Physical facilities and property have been provided and are maintained primarily for the academic and related functions of teaching, research, support services, and administration. Individuals and recognized organizations of the University community (students, faculty, staff, and alumni) may temporarily use or sponsor use of certain University facilities and properties in accordance with policies established by the President of the University. Board of Regents' rules. Non University entities whose activities relate to and further the mission and purposes of the University will be allowed to use University facilities and properties in accordance with the provisions of Presidential Memorandum #60 (Revised 9-28-84), entitled Use of University Property and facilities, and herein incorporated by reference and made part of these rules. However, as a general rule, entities which exist primarily for the purpose of carrying on commercial activity for profit, or which otherwise exist primarily for private individual gain or benefit, will not be permitted to use campus facilities.
